VALE: BILL THOMSON Life Member and a founder of the CCLCBC

Bill's daughter Cathy advised that Bill passed away on Friday 14th January 2017.

Bill Thomson first approached the Central Coast Leagues Club in 1987, in the hope that a local Bridge Club could be formed in the Gosford Area. Without a venue in Gosford, players would have to travel south to Brisbane Water or north to Long Jetty. Bill arranged an appointment with the Manager of the CCLC and, after a series of discussions, organised the first meeting of interested players in June 1987.

Bill was the Inaugural Vice President on the interim Committee formed on 29 August 1987. He served on the Committee for 15 years, being President on two occasions, Vice President on two occasions, Secretary for 5 years (one of the tougher jobs), Treasurer for 5 years and Committee person for 1 year. Bill also directed for at least 15 years and most of that time the Directors were totally voluntary. Bill was also a Congress Director and introduced many midweek Congresses at the Leagues Club.

Bill was always willing to promote the Bridge Club and regularly attended meetings with the other Internal Clubs and contributed to the Leagues Club Newsletters. He had a great rapport with the Management of the Leagues Club and had regular contact with the Manager and the Secretary. Every year the Bridge Club grew in recognition and was well supported by the Leagues Club.

Bill established many of the privileges we rather take for granted now such as our presentation dinners and trophies and special events such as our Melbourne Cup Day. In addition he was instrumental in organising the Perpetual Trophies which we present each year. During the first 10 years the Club Sessions grew from Monday night and Thursday daytime to 7 sessions per week.

Between 1987 and 1996 the CCLCBC grew to be one of the largest Bridge Clubs in NSW and the 23rd largest Club in Australia, with more than 422 members. I think this highlights the dedication of Bill and our other Bridge Club pioneers at that time.









At the AGM in 2012 Bill was made a Life Member of the CCLC Bridge Club in appreciation of his work on behalf of the Club. While all our voluntary committee members work very hard to run our club, we recognise the extra time and effort that was needed by those who set up the Club and started with not even a pack of cards.

Bill was also highly regarded for his pleasant, no fuss manner. This is not always easy considering the strong feelings that bridge often engenders. Being a Director as well as a frequent Committee person over the past 30 years required a firm hand in a velvet glove and Bill did this to perfection.

Bill also played in, and won, many of our Club events (see below). Bill played with many different players but most frequently with Jack Rushbrook, Bill Pinfold and Peter Berzins.

He and Peter also played golf together many years ago and as a friend he was hard to beat. We will miss him very much. Our sympathy goes out to Bill's wife Heather, his sons Robert and David and his daughter Cathy.

The NSWBA has announced the **2016 Congress Player of the Year** for masterpoints earned at NSWBA sponsored congresses. APPEALS

EVENT

CCLCBC conducts its events under the Tournament Regulations of the New South Wales Bridge Association (NSWBA). In practice, this means that if you and your partner feel compelled to appeal a decision of a Tournament Director (TD), you are appealing to the Appeals Committee of NSWBA, which provides the following advice on the process on their website.

REGULATIONS FOR APPEALS DESCRIPTION / ACTION

1.	An infraction occurs at the table and the TD is called	This may involve such things as an insufficient bid, lead out of turn etc. but the most common subjects that may lead to an appeal are misinformation, misexplanation, breaks in tempo and issues following from them.		
2.	The TD ascertains the facts and makes a ruling.	This ruling will generally be based on Bridge Law and the decision will usually protect the non-offending side. In some cases the facts may be disputed or be somewhat grey and the TD will interpret and rule as best they can in these circumstances.		
3.	Either pair may appeal the ruling OR the TD may instruct a pair to appeal	Each pair has the right to appeal the director's ruling. It is recommended that before making an appeal, the opinion of a designated "Appeals Advisor" be sought. The list of designated Appeals Advisors is posted on the notice board. If an Appeals Advisor is not present you may contact a member of council who might recommend a suitable person to advise you.		









4.	The appellants advise TD of their intention to appeal.	Once the decision has been made to appeal, the TD should be informed. He will then issue the appeals form.		
5.	The appeals form is completed.	There are three sections to be completed. These should be done in the order of 1) the appellants 2) the respondents 3) the TD. Before the appeal is heard, the director will supply each pair and each member of the Appeals Committee with a completed copy of the appeals form.		
6.	The TD advises the Appeals Coordinator (AC) of the appeal.	The AC will convene a panel of not less than three suitable people to hear the appeal, one of whom shall Chair the appeal. After consultation with all relevant parties, the AC will advise both pairs when the appeal will be held. As a general rule the appeal will be heard directly before the next session.		
7.	The appeal is heard.	The following steps will occur during the appeal The Chair will introduce all parties and outline the procedure The TD will explain their ruling The appellants will be allowed to present their case The respondents will be given the same opportunity Members of the appeals committee may ask questions The players leave and the committee makes a decision		
8.	The decision and reason for the decision are written on the appeals form.	The TD will be given the form and will then advise both pairs of the decision. The appeals process is an integral part of the game of Bridge and is designed to give players an opportunity to state their case in reference to an irregularity. As with all rulings it is rarely possible for both pairs to be completely satisfied with the outcome and players are asked to accept the decision in a sporting manner.		

Reviewing the ABF Appeals Reports makes interesting reading. In summary, the 28 Appeals listed on the website range from December 1998 to May 2015. The reasons for the Appeals are divided into the irregularities listed in the adjacent table. A 'break in tempo' is clearly the basis for most alleged infractions.

There is no right of appeal from any decision of an Appeals Committee, where duly constituted and conducted in accordance with the Regulations.
